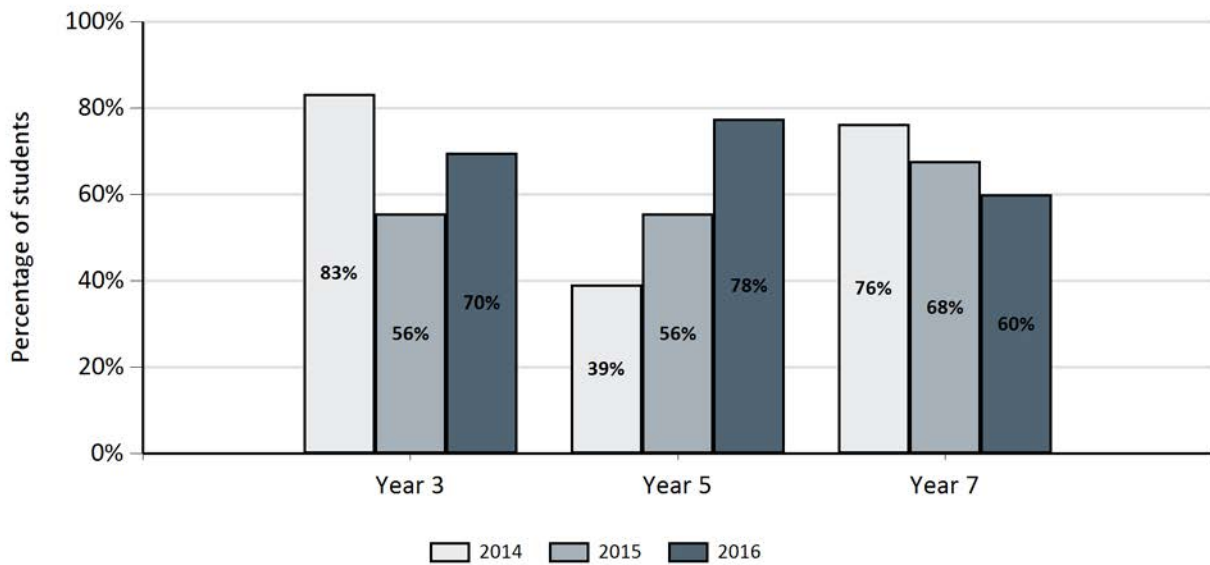

NAPLAN Proficiency

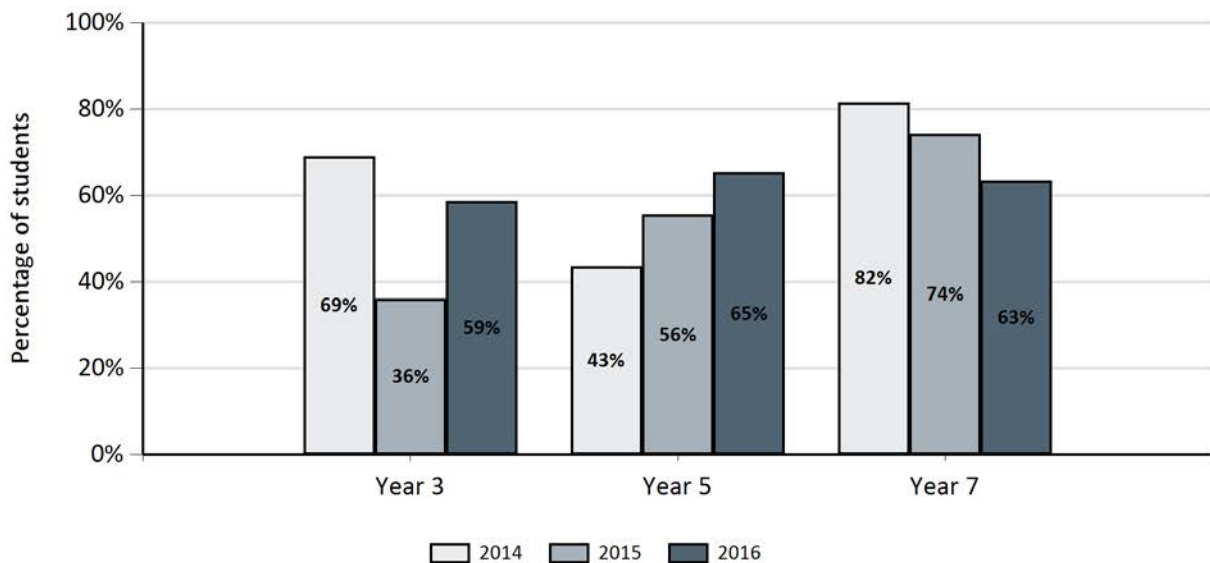
